# Chernobyl and Ukraine: Recovery from Catastrophe and the Renaissance of Nuclear Power June 25 - July 29, 2007



Learn firsthand about the environment, history and culture of Ukraine and the catastrophic explosion at the Chernobyl Nuclear Power Plant in 1986, and explore the implications of these events for the future of nuclear power.

This course may be taken either for academic credit or through Extended Education



A near meltdown of a nuclear reactor at Three Mile Island, Pennsylvania, in 1979 generated great concern about the safety of these machines. Even worse were the events in Ukraine in 1986. A reactor near the ancient Ukrainian village of Chernobyl exploded, sending radioactive debris over large areas of what are now Ukraine, Belarus and Russia. Considerable radioactive debris also fell in the rest of Europe, and the most heavily contaminated areas remain dangerous to this day. Ukraine is still recovering from the accident.

These two widely known accidents plus adverse economics left the nuclear power industry moribund for nearly thirty years. No utility company wanted to build a new reactor because of its negative public image.

Within the past year, however, several countries, including the United States, have submitted serious proposals to revive nuclear power to alleviate multiple problems associated with fossil fuels (oil, coal and gas). Proponents claim that new reactor designs minimize the fears raised by Three Mile Island and Chernobyl. Equally important, say proponents, nuclear power will alleviate global climate change and the insecurity of reliance on oil from the Middle East.

An important way to examine the proposal for a "nuclear renaissance" is to reconstruct the disaster at Chernobyl in 1986 and its aftermath, including its possible role in the dissolution of the Soviet Union. Ukraine became an independent republic in 1991.

This course offers an opportunity to study the impacts of the Chernobyl accident, especially on Ukraine, and thereby gain insights into the challenges posed by a nuclear renaissance.

This course may be taken for academic credit (4 or 8 credits). Community members may also register for the course through Extended Education.



#### **Academic Credit**

The class will meet in Olympia, WA, for the first three weeks (June 25 – July 13). Lectures and readings will outline the features of nuclear power, Ukraine's history, the accident, its consequences and the prospects of the proposed nuclear renaissance.

Students will reside in Kyiv, Ukraine, for the last two weeks (July 14 – 29). In Kyiv, the class will hear from individuals, government experts, environmental and health scientists, the media, non-governmental organizations and others. Course readings will consist of books and articles. Films and artistic exhibits will provide visual images. Field trips will introduce the city of Kyiv, including St. Sophia Cathedral, Lavra monastery and other major sights. There will be a one-day field trip to the reactor site and the abandoned towns of Pripyat and Chernobyl. Before this latter trip, the class will examine the risks associated with the radiation exposures at the reactor site. Visits to the reactor site are optional.

This course is for advanced undergraduates and graduate students in environmental studies, cultural studies, political economy, science-society relations, and science and public policy.

Undergraduates may register for 8 credit hours, and graduate students may register for 4 credit hours. Students must have junior standing or above. Students who have skills in Ukrainian or Russian language will have a richer experience, but these are not required. Enrollment in Evergreen's Summer School does not require formal admission to the College. Approval of the instructor is required for all participants. Contact John Perkins at perkinsj@evergreen.edu

In addition to tuition, participants will be responsible for paying their transport expenses, lodging, and food, both in Olympia and in Kyiv. The expenses to reach and stay in Kyiv are estimated to be about \$2,225 per person (double occupancy) or \$2,600 (single occupancy).

# **Payment Deadlines**

An application to enroll and a deposit of \$2225 (\$2600 single occupancy) are required no later than **Thursday, May 10, 2007**. Earlier is preferred. If expenses are lower than estimated, we will refund the difference. All fees will be refunded in full if the class is cancelled due to insufficient enrollment. These funds are refundable only at Evergreen's discretion if an applicant decides not to participate after Thursday, May 10, 2007.

Evergreen tuition and the remainder of the Extended Education fee are due no later than Wednesday, June 21, 2007.

# **Extended Education Participants**

There are two options available for those who do not want to register for academic credit. The fees for both these options include registration and class support fees, airfare and lodging.

**Option A:** 3 weeks in Olympia, Washington, and 2 weeks in Kyiv, Ukraine. Participants in this option will attend all lectures, films and field trips in Olympia and in Kyiv. Those who wish to discuss the readings will also attend a seminar class. The fee for this option is \$3,075 (double occupancy hotel) or \$3,450 (single occupancy hotel).

**Option B:** 2 weeks in Kyiv, Ukraine. Participants in this option will attend all lectures, films, and field trips in Kyiv. Those who wish to discuss the readings will also attend a seminar class. The fee for option B is \$2,825 (double occupancy hotel) or \$3,200 (single occupancy hotel).

Higher grade accommodations are possible for Extended Education participants wishing to make their own reservations. Details on hotel arrangements will be available after February 1, 2007.

Extended Education participants will not be expected to complete written assignments or exams. They will receive a Certificate of Participation in lieu of a formal academic evaluation. Extended Education participants have no prerequisites, but it is recommended that they have some background that prepares them for the material of this class. # **Travel Arrangements**

Group travel rates depend upon the class traveling together to Kyiv, departing Seattle on Saturday, July 14 and arriving in Kyiv on Sunday, July 15. The rate also depends upon returning as a group on Sunday, July 29. Participants may return independently of the group, but the airline will charge an additional fee for this option. Visas to Ukraine are not required for citizens of the United States, Canada, Japan or the European Union. Citizens of other countries may need visas. Passports are required.

#### **Instructors**

**John H. Perkins, Ph.D.** is a member of the faculty in environmental studies at The Evergreen State College. He has worked in this field for over 35 years, and his interests are in the history and public policy issues of environmental problems. Many of his publications deal with the issues of technology and agriculture. He received his B.A. in biology from Amherst College (1964) and his Ph.D. in biology from Harvard University (1969). He studied history of science and environmental history as a post-doctoral fellow at Harvard. Currently, he is editor-in-chief of *Environmental Practice*, published by Cambridge University Press for the National Association of Environmental Professionals.

**Tetyana Murza, M.E.S.**, received her master's degree in environmental studies from The Evergreen State College (2004) and her undergraduate degree in ecology and environmental protection from the Ukrainian State University of Water Management and Nature Conservation (2000). She has long-standing interests in nuclear power and its problems. She has worked with Ecoclub, a non-profit organization in Ukraine, and with the Nuclear Information and Resource Service, a non-profit in Washington, D.C. In April, 2006, she was the conference coordinator of the international conference, "Chernobyl+20: Remembrance for the Future," held in Kyiv.
