 2 to the taxes imposed by RCW 66.24.290 and 66.24.210 and to  
 3 reporting and bonding requirements as prescribed by regulations

 5 FURTHER, That nothing in this section shall prohibit a licensed  
 6 brewer or domestic winery, or a lessee of a licensed brewer or

 9 at a class H premises on the property on which the primary

 14 FURTHER, That nothing in this section shall prohibit a  
 15 manufacturer, importer, or wholesaler not licensed in this  
 16 state, or any person financially interested, directly or  
 17 indirectly, in such manufacturing, importing, or wholesaling  
 18 business from having a financial interest, direct or indirect,  
 19 in any licensed retail business or from owning any of the  
 20 property upon which such licensed retailer conducts its business  
 21 as long as the licensed retailer does not sell any brand of  
 22 liquor sold or distributed by such importer or wholesaler or  
 23 produced by such manufacturer doing business with the importer  
 24 or wholesaler as prescribed by rules adopted by the board under  
 25 chapter 34.04 RCW.

26 Financial interest, direct or indirect, as used in this  
 27 section, shall include any interest, whether by stock ownership,  
 28 mortgage, lien, or through interlocking directors, or otherwise.

31 NEW SECTION. Sec. 2. (1) The Evergreen State College  
32 shall no longer be deemed an institution of higher education for  
33 any such purposes on and after June 30, 1982 and at such time  
34 The Evergreen State College shall be deemed abolished.

35 (2) Prior to June 30, 1982, the President and staff of

1 The Evergreen State College shall turn over to the director of  
2 the Department of General Administration, all lands and physical  
3 properties, including buildings and equipment, of whatsoever  
4 kind, thereon, then belonging to the state college; the  
5 Department of General Administration shall thereafter manage  
6 such property in accordance with the directives of the Governor.

7 (3) Prior to June 30, 1982, the President and staff of  
8 The Evergreen State College shall turn over to the director of  
9 the office of Financial Management all records, moneys and  
10 accounts pertinent to the business of the state college; the  
11 office of financial management shall thereafter expedite the  
12 finishing of all business and financial matters relating to the  
13 said state college.

14 (4) The President and staff of The Evergreen State  
15 College shall forthwith make preparation for the closing of said  
16 institution of higher education in accordance with the purposes  
17 of this act.

18 (5) The statute law committee shall present for  
19 legislative consideration at the next session of the legislature  
20 a bill eliminating references throughout the Revised Code of  
21 Washington to The Evergreen State College; it is the intent and  
22 purpose of this act that any powers and duties presently  
23 existing in the text of such code relating to The Evergreen  
24 State College shall be null and void on and after June 30, 1982.

25 NEW SECTION. Sec. 3. Nothing in this act shall be  
26 construed to affect any existing rights acquired under the  
27 sections amended or repealed herein except as to The Evergreen  
28 State College and their officials, staff and employees, nor as  
29 affecting any actions, activities or proceedings validated  
30 thereunder, nor as affecting any civil or criminal proceedings  
31 instituted thereunder, nor any rule, regulation or order  
32 promulgated thereunder, nor any administrative action taken  
33 thereunder; and neither the abolition of The Evergreen State  
34 College nor any transfer of powers, duties and functions as  
35 provided herein, shall affect the validity of any act performed

1 by such agency or any officer thereof prior to June 30, 1982.

3 its application to any person or circumstance is held invalid,  
4 remainder of the act or the application of the provision to  
5 ot. r persons or circumstances is not affected.
