### Meeting Notes

Reviewed notes from 1/16 meeting. No changes.

Andi will present possible text regarding "required to report" possible misconduct.

Follow-up with Brian Walters, Sandy Yannone, and Nicole Ack re: academic integrity & bias statements incomplete per Andi & Wendy.

Reviewed edits to current draft of prohibitions that include:

- eliminating "failure to"
- adding preamble with values statement and delete before each prohibition

Determined to add:

- "attempting or engaging in" to the preamble
- changed "providing false information" to "Failure to be truthful and forthcoming to the College of a College official in all circumstances including but not limited to..."
- discussed at length maintaining "public appearance while under the influence of an illegal substance" with the "drug" prohibition. Postponed decision.

Wendy presented possible prohibition statement for hazing:

Hazing which includes but is not limited to any method of initiation into a student social, living or learning group, or any pastime or amusement engaged in with respect to such a group that causes, or is likely to cause, bodily danger or physical harm, or serious mental or emotional harm to another person.

Revised to reflect:

Hazing which includes but is not limited to any activity engaged in with respect to or method of initiation into a student social, living or learning group that causes, or is likely to cause, bodily danger or physical, mental, or emotional harm to another person.

Wendy presented the following possible prohibitions to identify in the Code:

- a. Refusal to desist from prohibited conduct.  
Determined to add as is.
- b. Failure to respond to any notice to appear for a meeting or hearing as part of the student conduct process.  
Determined to retain and combine with c.
- c. Failure to comply with a sanction imposed.  
Determined to retain and combine with b.
- d. Influencing, attempting to influence, or assisting another person to violate the Code.  
Modified to: Knowingly assisting or observing another person in violating the Code.
- e. Tampering with the election of any student, student organization or group.

Would this be covered under obstruction or disruption of college functions? If so, leave it out. Should consult with Student Activities before finalizing.

- f. Interfering with or abuse of the adjudicative process and disciplinary sanction.  
Add "adjudicative process" to "Obstruction of college function" prohibition.
