Results from Discussions Reflected in Final Recommendation and Report

May 5, 2010

Present: Wendy Endress, Tristan Powell, Andrea Seabert Olsen

Absent:

- Tristan raised concerns about the sexual misconduct standard and the Code not doing enough to protect survivors. He shared the sexual assault policy at Lafayette College that his friend was citing in her ILC on this issue. DTF is in agreement that the previous standard is preferable. Will need to consult with attorney to retain original text. Referred Tristan's friend to Phyllis Lane, who is chairing a sexual assault protocol work group, and to Talcott Broadhead, Coordinator of the Office of Sexual Assault Prevention.
- Discussed jurisdiction regarding misconduct on adjacent properties. Issues raised: April's recent example of \$15K worth of property theft by students of students who live in Coopers Glen, seamless way in which students view the two locations, off-campus students' expectation of privacy and independence, resources to respond to increased complaints from adjacent property incidents, pros/cons of imposing all standards off-campus (e.g. possession of a gun), lack of quantitative data to support adjacent property expansion, strong interest in supporting student living and learning experiences in a more seamless way – especially for those who engage seamlessly between adjacent property and College property, liability without resources. Postponed decision.
- Stalking. Issue of more than family being affected by stalking – e.g. roommates. Recommend change in language to “affiliated or associated with”.
- Recording. Concern raised re: law protecting media from recording without stating the fact. Recommend change to “except as permitted by law.”
