Overall: None of the reconstructions are adequate, but a combination of b and c would be.

Reconstruction b mistakes the conclusion for a premise and a premise for the conclusion.

- c. (1) An early-stage fetus lacks the capacity for sentience and cognition that would qualify it as a human person.
 - (2) Ending the life of something that doesn't qualify as a human person can sometimes be justified.
 - (3) If an early-stage fetus lacks the capacity for sentience and cognition that would qualify it as a human person and ending the life of something that doesn't qualify it as a human person can sometimes be justified, then abortion at an early stage of pregnancy can sometimes be justified.

 Reconstruction c states the conclusion too boldly ("often" rather than "sometimes"), but is otherwise adequate.

Books and magazines that use a vocabulary that deludes women into thinking themselves rebels and outlaws, on the cusp of some new freedom, misperceive our basic situation. - (3) It should not be easier for criminals to prey on law abiders. (IMPLICIT)
- ∴ Anti-gun laws should not be passed. (IMPLICIT)
